In order to generate interest and apprise church members of the purpose of the organization, flyers were created, printed and distributed.

Now, there are nine (9) members attending our meetings. Our officers are: Jeraldine Bailey, President; Alexis Wooten, Secretary; and Sandra Little, Treasurer. Other members include: Dr. Goldie Wells, Jurisdictional President; Dr. Tonya Hargett, Stephanie Graves, Jackie Mason, Jackie Tyson, and Rosanne Roberts.

We have chosen to collaborate with the Teen Ministry for our first project which is called "Chat and Chew." This project was held at 10:00 AM on April 27, 2019. The purpose of this event was to generate conversations between teens and people outside Wells Memorial COGIC.

The facilitators were administrators from Guilford County Schools, a member of the Greensboro Police Department, and a Community Resource Officer. Teens had the

opportunity to discuss various issues that pose challenges and those that they may feel uncomfortable discussing with church members. These issues: self-identity, self-esteem, peer pressure and more, may include things they are exposed to in everyday situations in school, on social media, and in their neighborhoods. The goal is for teens to know that this is a safe place to ask questions without being or feeling judged. Lunch was served at the end of the session.

# Report from the Southern California First Jurisdiction Chapter:

## LAUNCH "VISION 20/20" AT ITS ANNUAL JANUARY JUMPSTART Wanda Barnett Street, M.D. MPH, Chair – Atty. Sheila Bankhead Grisham, Co-Chair

On Saturday, January 19, 2019, the Business and Professional Women of Southern California First Jurisdiction launched "VISION 20/20" at our Annual 2019 "January Jumpstart." This event was presented under the leadership of Chair Wanda Barnett Street, M.D., MPH, and Co-Chair, Atty. Sheila Bankhead Grisham. Mother Barbara Mc Coo Lewis is the General Supervisor and the Jurisdictional Supervisor.

At this event, the discussion question exposed was, "What would you accomplish if you allowed God's unlimited power to be unleashed in your life?" The presenters were: Atty. Thanayi Lindsey, Atty. Margo Bouchet, Atty. Nekesha Lester Spinner, and Commissioner Jonae Watts. Crouch addressing the delegates from across the country nearly 70 years ago!

With only a few months until the eventful year, 2020-the year of the census, elections and redistricting, the State B&PWF determined the year 2019 would be a period of Preparation. We are

considering the number "9" being a time of gestation until birth. Therefore, being identified its "VISION 20|20" Strategic Stakeholders, Strategic Partners and Strategic Objectives. Clearly as the Bible states: "Where there is no vision, the people perish," (Prov. 29:18).

The Strategic Objectives included are: 1) Clarify your personal call and 20/20 VISION (Hab. 2:2-4. and Eph. 1:18, 19), 2) Mobilize the Women in the Districts, local churches and community to Maximize our Impact, voice and vote, and 3) Empower and Equip Women with "Power Tools" for Personal and Professional Development such as: Mentoring and virtual speakers and Master Classes. This is to prepare them to fulfill their mission and transform the lives of others.

We are currently preparing for our Phenomenal Women's Personal Development Conference on May 18, 2019 at the DoubleTree Hotel. We are featuring special guest speaker, Hon. Patricia Titus, Judge of the Los Angeles Superior Court celebrating 19 years on the bench. She highlighted her faith in God in her initial campaign race and defeated an incumbent to win her seat on the bench!

We hope to fulfill our scripture objective for the event, and the rest of the year, "To provoke others to love and good works" (Hebrews 10:24). No matter how much education, skills or talent you have, you can do nothing without the unlimited Power of God.
